GOVINDAN, Special Pary-in-Person of and · DR.K.R.RAMASWAMY, Government Pleader, on behalf of the Respondents 1 to 4, 6 and 7 and of M/S.R.MURALI, Advocate for 5th Respondent, the court made the following order:-

When this Public Interest Litigation was taken up today for hearing, the District Collector, Madurai, the Revenue Divisional Officer, Madurai, the Commissioner of Police, Madurai City and the Commissioner, Madurai Corporation, have filed independent counter affidavit/status reports.

- 2. The District Collector, in his report, has stated that by his proceedings in Roc.No.C2/14163/2015 dated 19.08.2016, he has formed a team to remove the unauthorised hoardings and banners in the entire district, based on G.O.No.19 Municipal Administration and Water Supply (MC1) Department, dated 02.02.2015. He has also mentioned the designations of all the officers, who are responsible for the compliance. He has further stated that there was a meeting held on 19.09.2016 attended to by the revenue as well as police officials, in which, it was instructed to the officials concerned to remove the unauthorised banners and to register a case against the He has further stated in paragraph 9 of the report that as many as 456 hoardings and, 565 unauthorised banners have been removed so far. He has further stated that as of now, there are no banners or hoardings in the City unauthorisedly put up. City, the Revenue Divisional Madurai Officer, Madurai and the Commissioner, Madurai Corporation, Madurai of Police, have also concurred with the statement of the District Collector.
- 3. When we requested the learned Special Government Pleader, as to what is the status of hoardings, flexboards, which have been unauthorisedly put up in the other Municipal Limits and the Corporation Limits, falling within the jurisdiction of this Court, the learned Special Government Pleader submitted that he has got no instructions as of now, because they are not parties.
- 4. In our considered view, since there is already an order by a Division Bench of the Principal bench imposing complete ban of these hoardings and flex boards, it is for the District Collectors of the Districts concerned to enforce the same and to ensure that there is no such unauthorised hoardings or flex boards etc., put up in their Since this is a public interest litigation, respective Districts. which has been filed with good intention in public interest and since there are reports that such kind of unauthorised advertisement boards, flex boards and hoardings have been put up in other places

also, we deem it appropriate to direct the District Collector concerned falling within the jurisdiction of this Court and the Superintendent of Police/Commissioner of Police, to remove the flex boards, hoardings, etc., which have been unauthorisedly put up, within their jurisdiction in the Municipal Towns and Corporations. The said exercise shall be completed on or before 07.10.2016.

- 5. The District Collector, Madurai, the Commissioner, Madurai Corporation, Madurai and the Commissioner of Police, Madurai City shall file additional status report, after verifying as to whether any such unauthorised flexboards/hoarding/banners have been left out and if anything inadvertently left out, the same shall be removed and reported.
 - 6. The Registry is directed to list the matter on 07,10.2016.
