All the members of the counselling teams are expected to serve the society diligently.



**The Team discussion the following decision was taken:-**

1. Four counselling teams may be formed which may be headed by Jurisdictional Inspectors of AWPS.
2. Each team may consist of a Psychologist, a Jurist and a Social Scientist.
3. Counselling teams may have 6 to 8 members and at a time minimum two members may be present during counselling.
4. Counselling team may provide mobile counselling on Saturday/Sunday to address problems of those needy people who suffer from stigma to visit Police Station/Court and provide solution to their problem at their door steps.
5. Lawyers may not be allowed during process of counselling. Available jurist/lawyers in the counselling team will guide them about legal procedures.
6. Lawyer in counselling team may not try to use opportunity to make clients during counselling.
7. An ethical committee may also be formed to regulate the behavior of counsellors.
